ANALYZE THIS! EQUIPMENT RENTAL AGREEMENT POLICY

- Computers are only to be used with the DARTFISH software for the Analyze This! Program. **No other software programs may be loaded onto the computers.**
- Equipment will **only** be rented to individuals who have been trained to use the DARTFISH software. Coaching Manitoba, in partnership with the University of Manitoba Biomechanics department will offer training to coaches at no charge.
- In the "Initial Equipment Received" column, initial the items you are renting.
- A damage deposit made payable to "Coaching Manitoba" must be provided by the borrower at the time of pick-up. The full amount will be refunded should all equipment be returned in good order. If equipment is not returned in good order, the borrower will be charged the full amount of the insurance deductible for replacement or repair.
- All equipment must be **returned** to the Coaching Manitoba office **at an agreed upon time and date.** Appointments can me made by contacting the Coach Education Coordinator at 925-5913.
- All equipment will be inventoried and checked for damage upon its return, with the borrower.
- Coaching Manitoba reserves the right to suspend borrowing privileges to coaches and/or Provincial Sport Organizations with outstanding claims.
- Coaching Manitoba reserves the right to refuse coaches and/or organizations borrowing privileges at any time.
